Royal Lake Resort No. 2, 50 Year Anniversary

March 27, 1957 Mr Eugene W. Whitler, Registered Illinois Land Surveyor #1460 certified that he had laid into lots, and streets land East of the Kaskaskia River in Clinton County Illinois and placed stones at each of the four corners that identify Royal Lake Resort No. 2.

May 14, 1957 the plat was presented to the County Board and a resolution duly approved and accepted the terms and conditions therein specified: Attest Ben Krimeyer, County Clerk and Henry Sorder Chairman.

April 1, 1957 Mr Seymour Goodman Owner and proprietor of the land described in the plat granted by quitclaim to the Townships of Wade, Carlyle, and West Lake, (now Santa Fa) the streets as shown on the plat for the use of all people as public streets.
